

Educational Workshop Series

Program Summary

In the late spring/early summer of 2019, several partner organizations convened to plan the details of a comprehensive, "back to basics" course for beginning farmers or as a way to 'refresh' on the basics for cattle farmers in the area. These coordinators, including the Lamar County SWCD Board, USDA—NRCS and the Lamar County UGA Cooperative Extension Service, created a monthly workshop series. These monthly programs were to be held on the third Thursday of every month, and they would include topics relevant to soil health, grazing system options and cattle nutrition.

With these principles in mind, the Lamar County Soil & Water Conservation District applied for the 'Conservation Innovation Grant' opportunity from the USDA—Natural Resources Conservation Service. Funding from this opportunity would financially assist the Conservation District with program materials, advertising and fully committing to the series for the next 11 months (August 2019—June 2020). Technical assistance for the program was provided by the USDA—Natural Resources Conservation Service (Carmen Westerfield, USDA—NRCS District Conservationist) and the Lamar County UGA Cooperative Extension Service (Hailey Robinson, Upson/Lamar Counties' Ag Extension Agent). These partners were invaluable in assessing the needs of the farmers in the Lamar County area.

The series successfully presented 7 monthly programs between August 2019—February 2020. Each program was capped with a meal to series registrants, and each program had a corresponding "program evaluation" to accompany other final results to be summarized and released upon the completion of the Conservation Innovation Grant with USDA—NRCS. Although the series was cut short due to public health concerns related to the historic COVID-19 global pandemic, the Lamar County Conservation District is committed to providing quality conservation education for its citizens and partners alike. As we continue to navigate the uncertainties surrounding public programming for our citizens, the District is working to find innovative ways to host hands-on and digital education presentations for its citizens.

Lamar County Wetland Nature Trail

The Lamar County SWCD continued its work on the local wetland nature trail, a unique outdoor experience for all kinds of citizens in Lamar County. This trail was constructed 20+ years ago, but gems such as these must be continually maintained, and we thought it was time for the first phase of some renovations! Many supervisors took part in a District "work day" on the trail, working to install new signage, repair cable along the trail path and other wooden structures along the trail. Lamar County Watershed Dams Inspections FY 2020

Local Soil & Water Conservation Districts, in partnership with local and state governments as well as USDA—Natural Resources Conservation Service, are charged with the safety and quality inspection of local watershed dams in the respective areas. Watershed structures no. 78 and no. 103 are located in Lamar County, and these structures are inspected annually by the Lamar County government, USDA—NRCS Barnesville Field Office and Lamar County SWCD. Noted repairs and maintenance are taken care of by the Lamar County Roads and Public Works Dept.
